30 DAYS TO FAMILY OHIO- RECOGNIZING THIS TREMENDOUS NEED, OHIO ATTORNEY GENERAL MIKE DEWINE'S OFFICE COMMITTED TWO YEARS OF VICTIMS OF CRIME ACT (VOCA) FUNDING TO KINNECT TO IMPLEMENT 30 DAYS TO FAMILY OHIO. THE PROGRAM IS A SHORT-TERM INTENSIVE INTERVENTION THAT MOVES CHILDREN FROM FOSTER CARE TO SAFE KINSHIP PLACEMENTS IN THE SHORTEST TIME POSSIBLE. 30 DAYS TO FAMILY OHIO USES EXTENSIVE FAMILY FINDING TO IDENTIFY KINSHIP PLACEMENTS AND CREATE A NETWORK OF SUPPORT TO ENSURE CHILDREN'S WELLBEING AND PLACEMENT STABILITY. THIRTY-ONE STAFF WORK ON 30 DAYS TO FAMILY OHIO THROUGHOUT THE STATE, WITH 17 OF THOSE POSITIONS FULLY FUNDED BY THE VOCA GRANT. SEVERAL OF OUR COUNTY PARTNERS HAVE CHOSEN TO ALLOCATE ADDITIONAL STAFF TO THE PROGRAM BEYOND GRANT FUNDING; THIS DEMONSTRATES THE INCREDIBLE NEED FOR INNOVATION IN THIS FIELD, AS WELL

CHOSEN AFFIRMING FAMILY MODEL- "YOUTH WHO IDENTIFY AS LGBTQ ARE OVER-REPRESENTED IN THE FOSTER CARE SYSTEM. A STUDY OF CHILDREN IN THE CUSTODY OF LOS ANGELES COUNTY FOUND THAT 19% IDENTIFIED ON THE LGBTQ SPECTRUM. MANY TIMES, CHILDREN ENTER CARE DUE TO REJECTION FROM THEIR BIOLOGICAL FAMILIES WHEN THEY BEGIN TO EXPLORE AND EXPRESS THEIR SOGIE. CUYAHOGA COUNTY RECENTLY COMPLETED A SURVEY OF THEIR SOCIAL WORK STAFF AND FOUND THAT ONLY 1.9% OF THE CHILDREN WERE IDENTIFIED ON THE LGBTQ SPECTRUM. THIS LOW NUMBER CAN BE ATTRIBUTED TO WORKER BIAS, DISCOMFORT WITH ENGAGEMENT OF THE YOUTH, AND THE PERCEIVED SAFETY RISK FOR THE YOUTH.
